The regular meeting of the Board of Supervisors was held in their chambers in the Court House, Chairman Philip Eygnor presiding.

The Pledge of Allegiance was led by Supervisor Bender.

The invocation was led by Chairman Eygnor.

Upon roll call, all Supervisors were present except Supervisors Donalty and Kolczynski.

County Attorney Daniel Connors and County Administrator Rick House were also present for this morning's session.

APPROVAL OF MINUTES:

Mr. Lasher moved, seconded by Mr. Chatfield, to waive the reading of the minutes of the June 21, 2022 meeting. Upon roll call, carried.

COMMUNICATIONS

The County Auditor's Accounts Payable Report for monthly utilities, miscellaneous payments including the July 7, 2022 warrants for accounts payable, totaling \$ 2,991,250.94 was received and filed.

A letter was received from Byron W. Brown, Mayor of Buffalo thanking Wayne County for the letter of support after the shootings on May 14, 2022.

The Wayne County Health Care Plan Trust Annual Report for fiscal year ending December 31, 2021 was received and filed.

A letter was received from New York State Homes and Community Renewal (OCR) announcing Wayne County's award of \$1,000,000 in CARES Act funding.

A letter was received from Assembly Minority Leader Will Barclay and Assemblyman Brian Manktelow, supporting the extension of the state's Zero-Emissions Credit (ZEC) program to allow for 20-year license extensions at RE Ginna Nuclear Power Plant, James A. Fitzpatrick Nuclear Power Plant and two reactors located at the Nine Mile Point Nuclear Facility. Copies of this letter were also sent to Governor Kathy Hochul, the Oswego County Legislature and Rory Christian, Chair and CEO of the New York State Department of Public Service.

A notice was received from the Town of Sterling in regards to a public hearing scheduled for Monday, July 18, 2022 at 7:05 p.m. at the Sterling Town Hall regarding Local Law #1, imposing a temporary moratorium on the acceptance and processing of special use permit applications related to bottled and/or bulk water sales within a one-half mile radius of the Village of Fair Haven's existing public water supply wells.

RESOLUTION 374-22: AUTHORIZATION TO INCREASE CONTRACT AMOUNT FOR CONSULTING SERVICES IN RELATION TO THE IMPLEMENTATION OF GOVERNMENTAL ACCOUNTING STANDARDS BOARD STATEMENT NUMBER 87

Mrs. Leonard presented the following:

WHEREAS, resolution 398-21 authorized the County to contract with Bonadio & Co., LLP for consulting services for the implementation of the Government Accounting Standards Board Statement Number 87 for an amount not to exceed \$10,000; and

WHEREAS, GASB Statement Number 87 requires governments to review and analyze all leases that they are currently a party to and determine the proper accounting application and financial reporting requirements for each lease; and

WHEREAS the objective of GASB Statement 87 is to better meet the informational needs of financial statement users by improving accounting and financial reporting for leases by governments; and

WHEREAS, GASB Statement Number 87 must be fully implemented by the end of the year 2022 to be in compliance with the financial standards of the Governmental Accounting Standards Board; and

WHEREAS, Bonadio & Co., LLP has requested additional funding in excess of the \$10,000 approved by resolution 398-21 due to the amount of leases the County is currently involved in, as well as the complexity of these lease agreements; and

WHEREAS, Bonadio & Co., LLP estimates that an additional \$15,000 is necessary to complete the implementation of GASB 87 and ensure compliance with their accounting reporting standards; and therefore now be it

RESOLVED, that the Chairman of the Board of Supervisors authorizes the amendment of the agreement with Bonadio & Co., LLP to increase the payment for services by \$15,000, for a total amount not to exceed \$25,000, to be billed at the hourly rates proposed in the original contract; and be it further

WHEREAS, the Human Resource Director provided a classification of Finance Clerk; and

WHEREAS, the County Treasurer wants to abolish both Account Clerk positions and create two Finance Clerks; and

WHEREAS, the incumbent Account Clerk meets the qualifications for appointment to the Finance Clerk position; now therefore be it

RESOLVED, that the County Treasurer is authorized to abolish two Account Clerk positions (pay-grade 10) in the Wayne County Treasurer's Office effective, July 21st, 2022; and be it further

WHEREAS, the County of Wayne took title to approximately forty (40) parcels on June 1, 2022 through the County's tax foreclosure process; and

WHEREAS, the former owner of one (1) parcel has filed litigation against the County in order to stop the sale of this tax foreclosed parcel:

Christopher Fowler – Tax ID # 69111-00-015548; and

WHEREAS, the legal challenge was filed within the required 30 days of the County receiving the default judgment of tax foreclosure; and

WHEREAS, the County Attorney and County Treasurer have reviewed the challenge and find it is in the County's best interest to settle the dispute as to this parcel without participating in litigation due to unique issues identified with respect to the parcel; now, therefore be it

RESOLVED, that the Chairman of the Board of Supervisors is authorized to sign any necessary paperwork to transfer said parcel back to the previous owner, on condition that the owner of the parcel pay in full the amounts of all property taxes which were written off by the County in anticipation of the tax foreclosure, together with the costs of all recording and filing fees necessary to re-convey title to the previous owner, subject to the approval of the County Attorney as to form and content.

Mr. Verno presented the following:

WHEREAS, the Wayne County Sheriff's Office has been holding Centralized Arraignment Part (CAP), at the Wayne County Jail for several months and will continue to do so for the unforeseen future. In addition, the command staff at the Sheriff's Road Patrol level has increased; and

WHEREAS the CAP arraignment room, located at the jail, and the Road Patrol Lieutenant's Office, located at the Wayne County Sheriff's Office, are both in need of office equipment (two desks), to keep daily operations organized and efficient; and

WHEREAS the Sheriff will be purchasing one desk for the CAP arraignment room using the jail revenue funds account at no cost to the taxpayer; and

WHEREAS, the Sheriff is requesting that the 2022 County Budget be amended and authorization be granted to purchase said desks in the amount of \$3,082.00 per desk with a zero net county cost; now therefore, be it

RESOLVED, that the Sheriff is hereby authorized to purchase said office equipment (two desks) for the Wayne County Jail facility and the Wayne County Sheriff's Office Road Patrol; and be it further

RESOLUTION 379-22: AUTHORIZATION TO DECLARE SINGLE SOURCE CONTRACTOR STATUS AND EXECUTE A CONTRACT WITH FINGER LAKES COMMUNICATION

Mr. Verno presented the following:

WHEREAS, Wayne County's public safety radio system is a custom designed system that

consists of equipment from various manufacturers, including Motorola, Harris, JPS, Bird Technologies, Zetron and Cambium Networks, and

WHEREAS, the system has been designed and built by Finger Lakes Communication Company, of Auburn, New York, and

WHEREAS, Finger Lakes Communication Company has demonstrated its ability to successfully build, expand as necessary and requested, and maintain the radio system infrastructure of Wayne County, and

WHEREAS, through previous resolutions and contracts (355-17 et al), Finger Lakes Communication has been declared a single source vendor for radio system infrastructure work, applicable to both repairs and maintenance of existing equipment and systems, as well as new system work to add to the public safety radio system infrastructure, which includes the radio dispatch consoles of 911, the microwave or other signal transmission network and tower equipment such as the transmitters and receivers, and

WHEREAS, The Federal Environmental Protection Agency (EPA) is expected to accept applications to the 2023 Brownfield Grant Program; and

WHEREAS, The New York State Department of Environmental Conservation (DEC) has programs to assist brownfield project; and

WHEREAS, to successfully apply and implement these State and Federal programs, the County expects to require grant writing and implementation assistance from qualified firms with strong environmental experience; now, therefore, be it

RESOLVED, that one part-time Account Clerk position be abolished effective February 2, 2023 and one part-time Outdoor Recreation Coordinator position be abolished January 1, 2023.

RESOLUTION 399-22: AUTHORIZATION FOR BOARD APPROVAL TO CHANGE THE STANDARD WORK DAY HOUR TO 7.50 FOR EMPLOYEES CURRENTLY WORKING 7.00 HOURS AND TO ENTER INTO AGREEMENT BETWEEN COUNTY OF WAYNE AND PROFESSIONAL SERVICE WORKERS LOCAL 81382 (IUE-CWA), CIVIL SERVICE EMPLOYEE ASSOCIATION, INC. CSEA LOCAL 859 GENERAL AND SUPERVISORY UNITS

Mr. Lasher presented the following:

WHEREAS, the purpose of this agreement between the County of Wayne and the Professional Service Workers (IUE-CWA) Local 81382, CSEA General and Supervisory Units, Local 859, and Managerial Confidential employees is to provide for stability and retention of staff for the management and the success of County operations, and

WHEREAS, through Labor-Management, the Parties have discussed a new work schedule for Wayne County full time employees currently working a thirty-five (35) hour work week to be increased to thirty-seven and one half (37.50) hour work plus a 30 minute unpaid meal period each day. This schedule was presented to employees for vote on June 17, 2022 and by majority vote, in favor of this new work schedule. This agreement does not alter employees currently working a 7.50 or 8 hour work day, and

WHEREAS, it is hereby agreed by and between the County of Wayne and each of the Unions and Managerial Confidential Staff joining as signatories to this Memorandum of Agreement as follows:

The parties agree as follows:

1. The regular work week of County employees shall be thirty-seven and one-half (37.50) hours per week, seven and one half (7.50) hours per day plus a thirty (30) minute unpaid meal period each day, Friday through Thursday with Saturdays and Sundays off, scheduled between 9:00 a.m. - 5:00 p.m.

Mental Health:

The regular work week shall be Monday through Friday, 37.50 hours per week, 7.5 hours per day plus a 30 minute unpaid meal period each day. To respond to client needs, department staff may be required to perform individual or group counseling and support services outside of normal clinical hours, and on Saturdays. In weeks when this occurs, department management will allow staff to adjust (flex) their work schedules to keep total work hours to 37.50 in the week.

Nursing Home:

Clerical Staff - the regular work week shall be 37.50 hours per week, scheduled between the hours of 7:30 a.m. to 10:00 p.m. In addition, there shall be a 30 minute unpaid meal period each day.

Employees whose coverage is required at irregular hours per day or daily: Social Work Assistant and Activity Aide - the regular work week shall be 37.50 hours per week plus a 30 minute unpaid meal period each day. The daily work periods shall be established by the department head according to the needs of the department.

2. Benefit Accruals (Annual, Sick and Holiday) will reflect a 7.50 hour work day beginning with payroll period January 1, 2023.

3. Employees will transition to the new work schedule beginning January 1, 2023, now therefore be it

RESOLVED, that the Chairman of the Board of Supervisors is authorized to sign this Memorandum of Agreement, subject to the review and approval of the County Attorney as to form and content.

RESOLUTION 400-22: AUTHORIZATION TO RESCIND RESOLUTION 277-22 AND ADOPT MANAGEMENT AND CONFIDENTIAL POSITION WAGE AND SALARY RANGES FOR 2023

WHEREAS, the Wayne County Local Law number 2-2014 gives the Board of Supervisors the authority to implement the Salary Plan for Managerial and Confidential Employees; and

WHEREAS, Wayne County will adjust the normal work week hours in the year 2023 for all full time employees currently working thirty-five (35) hours weekly to thirty-seven and one half (37.50) hours weekly, and

By making this adjustment to the pay plan structure, individuals who currently work thirty-seven and one half (37.50) or forty (40) hours weekly will be moved to the appropriate salary step to reflect a 2.50% increase; and

WHEREAS, the Director of Human Resources recommends that the 2022 Salary Schedule be increased by 7.14% prior to applying the 2023 cost of living adjustment (COLA) of 2.5% to align the 2023 salary schedule with the labor market; and

WHEREAS, the Pay Plan Committee has met and agreed to make changes within the Pay Plan Salary Administration; now, therefore be it

WHEREAS, the position of Head Social Welfare Examiner was abolished in 2021 and a Deputy Commissioner position was created – resulting in two Deputy Commissioner positions within the Department of Social Services; and

WHEREAS, one Deputy Commissioner is primarily responsible for the oversight of programs including Temporary Assistance to Needy Families (TANF) and Safety Net (SN), Supplemental Nutrition Assistance Program (SNAP), Medicaid, HEAP, the Childcare Assistance Program, and Workforce Development as well as the resource recovery efforts related to the issuance of public benefits and the other Deputy Commissioner position is responsible for the oversight of programs including Child and Family Services, Adult Services, and Child Support Services; and

WHEREAS, the support staff for the two Deputy Commissioners do not have the same title, though they both support the Deputy Commissioner titles; and

WHEREAS, the Department wants to ensure parity around staffing issues; and

WHEREAS, budgeted funds are presently available for such a position; now, therefore be it

RESOLVED, that the position of Secretary 1 is hereby created at a salary of \$34,270 in CSEA General grade 13, subject to the review of the County Attorney and Director of Human Resources; and be it further

RESOLVED, that the position of Senior Typist is hereby abolished upon hire of the Secretary 1; and be it further

RESOLVED, that the Wayne County Treasurer is hereby authorized to make the following budget amendment:

WHEREAS, the typical internship of this nature consists of 400 hours of work during two semesters of college, therefore, the approximate dates said intern would be working with the Department of Social Services would be from August 29, 2022 through May 12, 2023, supervised by Nikolette Vandermark, Department of Social Services CPS Case Supervisor and Tricia Snyder SUNY Brockport Field Education Coordinator; and

WHEREAS, said internship is dependent upon an Affiliation Agreement between the County of Wayne and SUNY Brockport College; and

WHEREAS, the Department of Social Services is requesting an Affiliation Agreement between the County of Wayne and SUNY Brockport College be executed and will provide such agreement; now, therefore, be it

RESOLVED, that the Chairman of the Wayne County Board of Supervisors is hereby authorized to execute an Affiliation Agreement for an undergraduate student internship with SUNY Brockport 350 New Campus Drive, Brockport, New York 14420, subject to the County Attorney's approval as to form and content.

WHEREAS, historically bidders have had 30 days from the date of the Board meeting to pay the balance of their approved bid; now therefore be it

RESOLVED, that the Board of Supervisors extends the deadline by 14 days to August 10th, 2022 at 3 pm.

County Wide Ambulance Update
