Teamsters Local 118 represents the Sergeant/Investigator, Sergeant, Deputy Sheriff Investigator or Deputy Sheriff in the following divisions of the Office of the Wayne County Sheriff: Detective, Juvenile, Civil or Road Patrol Divisions.

Negotiations between the Union and Wayne County began on February 10, 2022. The Union and the County met for a total of nine negotiation sessions as follows:

February 10, 2022 March 18, 2022 April 8, 2022 April 25, 2022 May 9, 2022 June 2, 2022 June 22, 2022 July 26, 2022 August 19, 2022

During these sessions, the Union presented both economic and non-economic proposals. The County presented a non-economic and eventually an economic counter that was included in a package deal tied to the other proposals. The Union countered the Counties economic proposal. The County advised that their next offer would be "unofficial". The current economic proposals leave the Union and County far apart economically.
