

## Wayne County Official List of Nominations for the General Election to be held November 7, 2017

To the Voters of the County of Wayne, State of New York: It is hereby certified, pursuant to the provisions of Section 4-122 of the Election Law, that the following named persons have been nominated as the candidates for the respective offices named herein to be voted for at the next General Election to be held on the seventh day of November, 2017.

**Proposal Number One, A Question - Constitutional Convention** - Shall there be a convention to revise the Constitution and amend the same?

**Proposal Number Two, An Amendment - Allowing the complete or partial forfeiture of a public officer's pension if he or she is convicted of a certain type of felony** - The proposed amendment to section 7 of Article 2 of the State Constitution would allow a court to reduce or revoke the public pension of a public officer who is convicted of a felony that has a direct and actual relationship to the performance of the public officer's existing duties. Shall the proposed amendment be approved?

**Proposal Number Three, An Amendment - Authorizing the Use of Forest Preserve Land for Specified Purposes** - The proposed amendment will create a land account with up to 250 acres of forest preserve land eligible for use by towns, villages, and counties that have no viable alternative to using forest preserve land to address specific public health and safety concerns; as a substitute for the land removed from the forest preserve, another 250 acres of land, will be added to the forest preserve, subject to legislative approval. The proposed amendment also will allow bicycle trails and certain public utility lines to be located within the width of specified highways that cross the forest preserve while minimizing removal of trees and vegetation. Shall the proposed amendment be approved?

**Proposal Number Four, Town Proposition Number One**

Palmyra Heated Highway Facility - Shall the bond resolution adopted by the Town Board of the Town of Palmyra, New York dated September 28, 2017, authorizing the issuance of up to \$391,000.00 of general obligation serial bonds of the Town to pay a portion of the costs for the construction of a new Palmyra Heated Highway Facility and other incidental improvements, machinery and equipment in connection therewith for such construction and Town uses at a maximum aggregate cost of \$760,000.00 with the balance of said costs to be provided by (a) up to \$325,000.00 to be appropriated from sales tax revenue from 2018 and (b) \$28,000.00 from Rental of Real Property and (c) \$16,000.00 from the Unappropriated Funds Balance in the General Fund providing for the issuance of bond anticipation notes; determining that the period of probable usefulness thereof and maximum permissible term of any borrowing is 15 years and pledging the faith and credit of the Town to the payment of such obligations and interest thereon be approved?
