NOTICE is HEREBY GIVEN that the Board of Supervisors of the County of Wayne, at a meeting thereof held on the 17th day of January 1967, duly adopted on said day a Local Law, being Local Law No. 1 of 1967, reading as follows:

LOCAL LAW NO. 1 YEAR 1967 COUNTY OF WAYNE, NEW YORK

A LOCAL LAW TO ESTABLISH PARKING RULES AND REGULATIONS FOR THE USE OF THE COUNTY PARKING LOT IN THE REAR OF THE COUNTY OFFICE BUILDING

BE IT ENACTED by the Board of Supervisors of the County of Wayne as follows:

1. Pursuant to the provisions of Section 215 subdivision 11 of the County Law the following rules and regulations are hereby established for parking in the County Parking Lot in the rear of the County Office Building:

- (a) Only automobiles of County employees or persons on County business shall be parked in the parking lot.
- (b) No automobiles shall be parked in said parking lot between the hours of 2:00 a.m. and 6:00 a.m. daily.

2. Violations of said rules and regulations shall constitute an offense and shall be punished by a fine not exceeding \$100.00 or by imprisonment not exceeding 30 days or by both such fine and imprisonment.

3. This Local Law shall take effect immediately.

NOTICE IS HEREBY GIVEN that there has been duly presented to the Board of Supervisors of the County of Wayne, New York, on January 3, 1967, Local Law No. 1 of the year 1967, entitled "A Local Law to Establish Rules and Regulations for the Use of the County Parking Lot in the Rear of the County Office Building".
