
Dear Gary:

Local Law No. 1 of the year 19 72

A local law affecting compensation of county elected and appointed officers during their term of office. (Insert title)

SECTION 1. The annual salary of the Superintendent of Highways shall be, and it is hereby increased from \$17,800.00 per year to \$18,500.00 per year effective January 1, 1972.

SECTION 2. The annual salary of the Commissioner of Social Services shall be, and it is hereby increased from \$16,800.00 per year to \$17,500.00 per year effective January 1, 1972.

SECTION 3. The annual salaries of the County Judges (Family and Surrogates) shall be, and they are hereby increased from \$26,000.00 per year to \$28,000.00 per year effective January 1, 1972.

SECTION 4. This local law shall take effect immediately upon final passage and due filing.


