- SECTION 3. The annual salaries of the County Judges (Family and Surrogates) shall be, and they are hereby increased from \$28,000. per year to \$29,075. per year effective January 1, 1973.
- SECTION 4. This local law shall take effect immediately upon final passage and due filing.
