RESOLUTION NO. 259-93

ADOPT LOCAL LAW AUTHORIZING THE COUNTY OF WAYNE TO LEASE
REAL PROPERTY FOR COUNTY PURPOSES FOR TERMS
NOT EXCEEDING THIRTY YEARS

Mrs. Deyo presented the following:

WHEREAS, a proposed local law in relation to authorizing the County of Wayne to lease real property for County purposes for terms not exceeding thirty years was presented to the Board of Supervisors on May 3, 1993; and

WHEREAS, a public hearing on the proposed local law was held by the Board of Supervisors on May 18, 1993, in accordance with the notice of hearing duly posted and published in the manner prescribed by law; now, therefore, be it

RESOLVED, that said local law is hereby adopted to read as follows:

LOCAL LAW NO. 3 - 1993
COUNTY OF WAYNE - STATE OF NEW YORK

A local law authorizing the County of Wayne to lease real property for County purposes for terms not exceeding thirty years.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF WAYNE, as follows:

SECTION 1.

The intent of this local law is to supersede the provisions of subdivision 3 of Section 215 of the County Law for the purpose of enabling the County of Wayne to lease real property for County purposes for terms exceeding five (5) years.

SECTION 2.

Notwithstanding the provisions of subdivision 3 of Section 215 of the County Law, the Board of Supervisors of the County of Wayne may lease real property for County purposes for terms not exceeding thirty (30) years with the privilege of renewal.

SECTION 3.

Local Law No. 2 of the year 1986 is hereby repealed.

SECTION 4.

This local law shall take effect immediately upon the date it is filed in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law of the State of New York;

and be it further

RESOLVED, that the Clerk of the Board of Supervisors is hereby directed to number the local law in conformance with the filing requirements of the Secretary of State and to file the local law with the Secretary of State in accordance with the provisions of the Municipal Home Rule Law of the State of New York.

Mr. Fabino moved the adoption of the resolution. Seconded by Mr. Spickerman. Upon roll call, all Supervisors voted Aye. The Chairman declared the resolution adopted.
