Local Law No. 3 of the year 19 90

A local law providing for changes in the salaries of certain County Officers

Be it enacted by the BOARD OF SUPERVISORS of the

SECTION 1. The annual salary of the County Treasurer is hereby increased from \$32,996 to 34,600 effective January 1, 1990.

SECTION 2. The annual salary of the Commissioner of Social Services is hereby increased from \$47,985 to \$50,380 effective January 1, 1990.

SECTION 3. The annual salary of the Director of Real Property Tax Services is hereby increased from \$33,600 to \$35,280 effective January 1, 1990.

SECTION 4. The annual salary of the County Fire Coordinator is hereby increased from \$13,860 to \$14,550 effective January 1, 1990.

SECTION 5. The annual salary of the Superintendent of Highways is hereby increased from \$40,500 to \$42,525 effective January 1, 1990.

SECTION 6. The annual salary of the Planning Director is hereby increased from \$28,350 to \$31,000 effective January 1, 1990.

SECTION 7. The annual salary of the Personnel Officer is hereby increased from \$27,500 to \$30,000 effective January 1, 1990.

SECTION 8. The annual salary of each Election Commissioner is hereby increased from \$6,562 to \$6,900 effective January 1, 1990.

SECTION 9. An incumbent holding a position specified in this local law at any time during the period from January 1, 1990, until the time when basic annual salaries are first paid pursuant to this local law for such service in excess of the compensation actually received therefore, shall be entitled to a lump-sum payment for the difference between the salary to which such incumbent was entitled for such service and the compensation actually received after this local law becomes effective.

SECTION 10. If any clause, sentence, paragraph, part or provision of this local law shall for any reason be adjudged by any court of competent jurisdiction to be invalid, such judgement shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its effect and operation to the clause, sentence, paragraph, part or provision thereof directly involved in the controversy in which such judgement is rendered.

SECTION 11. This local law is adopted subject to a permissive

**NOTICE OF ADOPTION OF LOCAL LAW**  
**SUBJECT TO PERMISSIVE REFERENDUM**

NOTICE IS HEREBY GIVEN that a local law providing for an increase in the salary of the Planning Director was duly adopted by the Wayne County Board of Supervisors on August 21, 1990.

NOTICE IS HEREBY FURTHER GIVEN that said local law is subject to a permissive referendum of the qualified electors of the County of Wayne. Such referendum may be required by the filing of a petition protesting against such local law signed and authenticated as required by Section 24 of the Municipal Home Rule Law of the State of New York by qualified electors of Wayne County registered to vote therein at the last preceding general election, in number equal to at least ten percentum (10%) of the total number of votes cast for Governor at the last gubernatorial election in the County. The petition must be filed within forty-five (45) days from the date hereof with the undersigned Clerk of the Board of Supervisors of the County of Wayne at her office in the County Court House, 26 Church Street, Lyons, New York.

**COUNTY OF WAYNE - STATE OF NEW YORK**

A local law providing for an increase in the salary of the Planning Director.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF WAYNE, as follows:

Section 1.

(a) The Planning Director shall receive \$2,000 as compensation additional to the annual salary of \$31,000 now received by the Planning Director, effective July 17, 1990.

(b) The additional compensation shall be pro-rated and paid during the period from July 17, 1990, through December 31, 1990.

Section 2.

This local law is adopted subject to a permissive referendum, and the Clerk of the Board of Supervisors shall give public notice thereof in the manner required by law.

Section 3.

This local law shall take effect on the date it is filed in the office of the Secretary of State as provided in Section 27 of the Municipal Home Rule Law of the State of New York.
