RESOLUTION NO. 289-13: ADOPTION OF LOCAL LAW TO INSERT INFORMATION REGARDING THE COST OF STATE MANDATES INTO THE TAX BILL FOR COUNTY PURPOSES

Mr. Hammond presented the following:

WHEREAS, Section 922 of the Real Property Tax Law allows the Wayne County Board of Supervisors to set the format of the Town and County Tax Bill; and

WHEREAS, a local law is required to insert information into the tax bill for county purposes; and

WHEREAS, said proposed local law was presented to the Board of Supervisors on March 19, 2013; and

WHEREAS, a public hearing on the proposed local law was held on April 16, 2013 at 9:10 a.m. in accordance with the notice of hearing duly posted and published in the manner prescribed by law; now, therefore, be it

RESOLVED, that said local law is hereby adopted to read as follows:

COUNTY OF WAYNE - STATE OF NEW YORK
LOCAL LAW NO. 3 FOR THE YEAR 2013

A local law authorizing Wayne County to insert information into the tax bill for county purposes:
BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF WAYNE, as follows:

SECTION 1. LEGISLATIVE FINDINGS AND PURPOSE

Section 922 of the Real Property Tax Law provides the form and content of the town and county tax bill to be mailed by the collecting officer in each town and showing the amount of taxes due on each party.

- a. The Costs of State Mandated programs and services exceed the amount of the Property Tax Levy in Wayne County.
- b. It is important for the taxpayers of Wayne County to be aware of the costs of State Mandated programs to Wayne County government and to the taxpayers.
- c. It is important that Wayne County residents are notified of the cost of the State Mandated programs and services.

SECTION 2. COUNTY TAX BILL INSERT

Information notifying county residents of the costs to Wayne County of State Mandates and Services will be distributed as a separate enclosure inserted into the tax bill mailing.

SECTION 3. EFFECTIVE DATE

This local law shall take effect immediately upon the date it is filed in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law of the State of New York.
